- a. **VIVA Software Solution (VSS) (Since 2016-17):** Similar to its implementation in administration, VIVA Software Solution is also applied in the domain of finance and accounts. It is used for generation of fee receipt, balance of remaining amount etc.
- b. **Tally ERP-9 (2010-11):** It was Implemented since 2010-11, Tally ERP-9 was widely used as accounting software that helped to manage financial transactions and accounts.
- c. **Tally Prime Gold (2023):** The implementation of Tally Prime Gold was done from 2023, it is the upgraded or a newer version of Tally used initially.
- d. **Online Payments (2015-16): Introduced in 2015-16, the online payments:** This system suggests a move towards digital transactions and payment processing in the financial domain.

- a. **DTE (2015-16):** The Directorate of Technical Education (DTE) system was implemented in 2015-16, in order to manage technical education-related processes like admission and support.
- b. **State CET Cell (2013-14):** Implemented since 2013-14, the State Common Entrance Test (CET) Cell system is associated with managing the common entrance exams for admission, admission procedures and allotment of Institute.
- c. **Fee Regulating Authority (2017-18):** Implemented in 2017-18, this system is involved in regulating and managing educational fees.
- d. **Maha DBT (2018-19):** The Maha Direct Benefit Transfer system, implemented in 2018-19, aims to providing direct financial assistance to students.
- e. **DELNET (2022-23):** Implemented in 2022-23 in VIVA Institute of Pharmacy, DELNET is a network for resource-sharing among libraries in India.
- f. **National Digital Library (8/4/2021):** Subscribed on August 4, 2021, the National Digital Library is a digital repository of educational resources.
- g. **Ex-Pharma Series (2021-22):** This Software was purchased for first time in 2021-22 by VIVA Institute of Pharmacy, this system is associated with the pharmacological series, potentially related to experimentation on animal models.
- h. **Google Classroom (2019-20):** Google Classrooms were started more prominently in 2019-20, during Covid-19 pandemic. Google Classroom is a platform for online education, sharing Study material and collaboration.
