- **Conclusion**
- **References**
- The **text** should be formatted in **Times New Roman**, font size **12**, with a word limit of not more than **250**.
- The presenting author is required to be a **registered delegate** of the conference.
- Each registered delegate is permitted to submit a maximum of **one abstract** as the **first author**.
- Maximum no. of participants in a group is **4** delegate.

Guidelines for Poster Presentation



- **Poster Size** : 4 ft. (height) x 3 ft (width)
- **Font Style** : Time New Roman
- **5 mins** for presentation and **3 mins** for Q and A
- Ensure content should be readable
- Identity of the participants should not be disclosed
- Decision of judges will be final

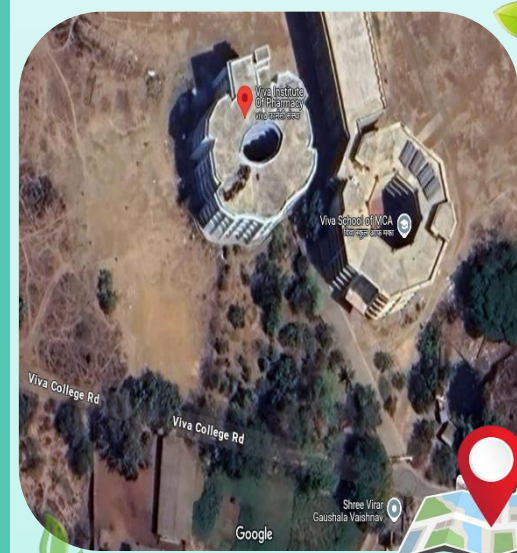
