Terms of MoU:

1. Making facilities and software of one party available to students from the other party for mutually agreed community pharmacy practical training program.
2. Institute shall select students eligible for the training program, provide necessary supervision, and ensure that students adhere to Pharmacy's rules and regulations during the training period.
3. The pharmacy shall provide practical insights, hands-on experience, and ensure the safety of the students.
4. The Parties shall maintain the confidentiality of any proprietary information, trade secrets, or patient data encountered during the training, and ensure the students are educated about the importance of confidentiality.
5. As required, Institute shall provide volunteers for health checkup programs if arranged by Pharmacy.
6. This MoU shall become effective on the date it is signed by the parties and shall be valid for One year. Thereafter, This MOU may terminate by either party upon 1 month notice in writing.
7. All joint activities not completed at the expiration or termination of this MoU may be continued for a further year until their completion under the terms of this MoU.
8. All questions related to this MoU arising during its term will be settled by the parties by mutual agreement.
